

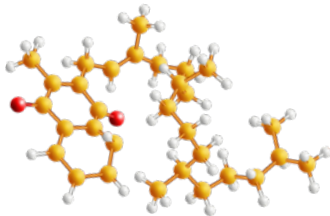

Essentially, Vitamin K<sub>2</sub> MK-7 promotes the retention of calcium in healthy bone while discouraging its being deposited in other tissues causing undesirable calcification of arteries, heart valves, etc. By discouraging calcification, Vitamin K<sub>2</sub> MK-7 promotes flexible, resilient arteries and heart valves, which is a defining characteristic of cardiovascular health. In short, Vitamin K<sub>2</sub> MK-7 acts like a "traffic cop" directing calcium to the vital tissues where it is required while keeping it out of those where it is not desired. Since we all must consume calcium daily our healthy bones and flexible arteries require Vitamin K<sub>2</sub> MK-7. Sadly, there is no significant source of Vitamin K<sub>2</sub> MK-7 in the typical American diet making supplementation the only reliable method of acquiring this essential vitamin.
